- 5. <u>Mayor's report</u> Mayor Puckett gave the monthly court report as follows: for the month of March Mayor's Court had computer fund I \$240, costs \$550, fines \$1325, Niles Municipal Court fines \$1160.34 parking tickets \$90, reports \$5 for a grand total of \$3370.34.
- 6. Report of Village Officials:

**Village Administrator Thomas Domitrovich** stated that curbside stick pick up will resume tomorrow and continue through the summer.

-the VA met with GPD regarding the bid specs for the 2018 Road Resurfacing Project. A few minor changes were made and the specs are being reviewed by the Solicitor.

-the VA attended a meeting of the Trumbull County Council of Governments on March 28. The Village is going to join the COG at a cost of \$100 per year. They have bylaws and are recognized by the State of Ohio. They will meet quarterly.

-the VA and Mayor met with the Trumbull County Engineer's office regarding shared services/equipment and the bulk purchase of salt. Their bulk rate is slightly lower but we have to pick up the salt as opposed to having it delivered directly to the Village as Morton currently does.

Police Chief Bill Woodley distributed his end of the month report as follows: For the month of March the Police Department received 191 calls form the 911 center. They conducted 72 traffic stops resulting in 20 traffic citations. They made 13 criminal arrests. They responded to 3 animal complaints, 7 alarms drops, 4 parking complaints, 1 call for suspicious activity, 2 calls for suspicious person, 6 calls for a suspicious vehicle, 2 stand by calls, 2 calls for threats made, and 19 medical calls. They conducted 4 residential security checks and completed 2 hours of continued police training as well as their daily training bulletins. Officers Jones and Walp were in attendance for the senior class walk out in protest of gun

**Fire Chief Todd Stitt** had previously distributed his end of the month report as follows: for the month of March the Fire Department responded to 17 EMS calls and 6 fire calls. They are working on a smoke alarm campaign with the American Red Cross. Firefighter Robert Golden passed his EMT course. They are having some safety issues with their radio coverage and are looking into a few ideas on how to fix it.

Park & Buildings Mr. Harvey stated that Park and Buildings met last evening and discussed the Relay for Life; plans are moving along. The Easter egg hunt was a success thanks to the Girl Scouts and others who helped. There were over 4000 eggs and it was very well attended. They discussed the Positive Impact Day which will be held on May 9 and they hope to have a good turnout. The 100th anniversary committee is working on a number of ideas such as bands, games, food vendors etc. They discussed the basketball courts and that will be brought up again next meeting. They also discussed park attendants.

guardrail on Marshall Road and whether it was needed. There is a second reading of the salary ordinance for an increase for the police department and Safety supports it.

**Finance & Capital Improvement Mr. Lewis** stated Finance met last evening and discussed the purchase of the excavator which has been budgeted. There is a slight increase in price but it will be handled within the budget. He also stated that he will be setting meetings with the department heads soon to discuss the 2019 budgets.

Service Committee Mr. Fisher stated Service met Tuesday morning at 8:30 a.m. and discussed the Niles sewer agreement. There was no update at this time since the Solicitor is reviewing the paperwork and it will be kept on their agenda. They also discussed the COG meeting for shared services with a membership fee of \$100. The also talked about the solicitor's agreement, health care options, and the accepted bid from Wolford of \$6500 for the demolition of 328 Illinois Ave. They discussed the NOPEC energy grant, and road paving on Parkside Place.
