

VILLAGE OF McDONALD, OHIO

ORDINANCE NO. 3203-17

AN ORDINANCE FOR THE PURPOSE OF AMENDING PREVIOUS ORDINANCE NO. 3178-15 CONCERNING THE APPOINTED POSITION OF VILLAGE FISCAL OFFICER CREATED IN ACCORDANCE WITH SECTION 733.262 OF THE OHIO REVISED CODE, and declaring an emergency.

WHEREAS, Village Council previously passed Ordinance No. 3178-15 amending the work schedule and compensation of the position of Village Fiscal Officer; and

WHEREAS, to accommodate the request of the Fiscal Officer, and to provide more time for this position for the fiscal health of the Village, Village Council desires to amend Ordinance No. 3178-15 to make the Fiscal Officer position a full-time position and revise the compensation accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF McDONALD, TRUMBULL COUNTY, STATE OF OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING:

Clause I. Ordinance Number 3178-15 which presently reads, in pertinent part, as follows:

Section I. In accordance with Section 733.262(B) of the Ohio Revised Code, and due to the vacancy in the position of the Village Clerk, there is hereby created the appointed position of a Village Fiscal Officer. The salary of the Village Fiscal Officer shall be One Thousand Seven Hundred and no/100 Dollars (\$1,700.00) per month. No benefits, insurance, holiday pay or vacation pay is offered with this position.

Section II. All aspects pertaining to the appointment, removal, and duties of the Village Fiscal Officer are set forth in accordance with Section 733.262 of the Ohio Revised Code. The Village Fiscal Officer shall have those powers, duties, and functions as provided by the general laws of the State of Ohio.

Be and the same is hereby amended to read as follows:

Section I. In accordance with Section 733.262(B) of the Ohio Revised Code, and due to the vacancy in the position of the Village Clerk, there is hereby created the appointed position of a full-time Village Fiscal Officer. The salary of the Village Fiscal Officer shall be as follows:

1. for the first six months of employment \$15.81 per hour;
2. for the second six months of employment \$16.69 per hour;
3. after one year of employment \$17.36 per hour.

Section II. All aspects pertaining to the appointment, removal, and duties of Village Fiscal Officer are set forth in accordance with Ohio Revised Code Section 733.262. The Village Fiscal Officer shall have those powers, duties, and functions as provided by the general laws of the State of Ohio.

Clause II. Sections I and II of existing Ordinance No. 3178-15 are hereby repealed, and amended as set forth herein.

Clause III. Any Ordinance or Resolution, or parts thereof, inconsistent or in conflict with the terms, covenants, and conditions of this Ordinance are hereby repealed, rescinded, vacated, rendered null and void, and held for naught.

Clause IV. The passage of this Ordinance and all deliberations relating to the passage of this Ordinance were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.

Clause V. To preserve the financial health and welfare of the Village by adding additional work hours to the position of the Village Fiscal Officer, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in full legal force and effect from and after the earliest period allowed by law. Further, it is Council's intent that this Ordinance be applied retroactively to January 1, 2017 to account for the fact the Village Fiscal Officer has been working full time since January 1, 2017.
