

NOTICE FOR SEALED BIDS

SEALED BIDS for the **Municipal Solid Waste Collection Services** within the Village of McDonald, Trumbull County, Ohio, will be received by the Village Clerk at the Village of McDonald Municipal Building, 451 Ohio Avenue, McDonald, Ohio 44437, until 12:00 o'clock noon on Tuesday, March 26, 2019. The bids received are for the operation of a Municipal Solid Waste collection and disposal program for each Residential Unit in the Village of McDonald, from June 1, 2019 to May 31, 2022. Bids will be opened and publicly read at 12:00 o'clock noon on Tuesday, March 26, 2019, at the Village of McDonald Municipal Building, 451 Ohio Avenue, McDonald, Ohio 44437.

Copies of the complete Bid Manual may be obtained beginning Monday, March 11, 2019, at the non-refundable cost of Twenty-Five Dollars (\$25.00). You may inquire at the front counter in the Municipal Building or email your request to: mcdoffice@zoominternet.net. Each manual contains the specifications, details, bidding, and contract documents for the project. The Bid Manual may be mailed via US Postal Service upon the non-refundable payment of Thirty Dollars (\$30.00). Checks shall be made payable to Village of McDonald. Mailings shall be addressed to:

Each bid must be accompanied by a bid guarantee in accordance with Section 153.54 of the Ohio Revised Code. Each bidder shall submit either a bid guaranty bond in the amount of 100% of the bid, **OR** a certified check in the amount of 10% of the proposal, made payable to the Village of McDonald. A bid guarantee filed in the form of a bond shall be in the form of the bond included in the Bidding Documents. A bid guarantee filed in the form of a certified check shall be conditioned to provide that, if the bid is accepted, the Bidder will, after the award of the contract, enter into a proper contract in accordance with the specifications, details, bidding, and contract documents.

Bids must be presented in a sealed envelope marked “**Municipal Solid Waste Collection Services**” by the date and time of bid opening. Bids may be forwarded by registered or certified mail addressed to:
