

LEGAL NOTICE

VILLAGE OF McDONALD – 2023 STREET RESURFACING PROJECT

Sealed bids will be received at the Village of McDonald, 500 Ohio Ave., McDonald, Ohio 44437, up to the hour of 12:15 PM, local time on the 15th day of September 2023 and read publicly thereafter, by Village representatives and GPD Group, for the following:

VILLAGE OF McDONALD – 2023 STREET RESURFACING PROJECT

The project will consist of pavement resurfacing of 0.40 miles of the following roadway sections:

- W. 2nd Street (Near Stadium) – 3” milling & resurfacing (Approx. 775’ L x 10’ W)
- W. 3rd Street (W. 2nd Street to Illinois Avenue) – 2” milling & resurfacing, 2’ wide compacted aggregate shoulder (north side)

The work will include the milling and profiling to establish a desired cross-slope along with asphalt pavement resurfacing of approximately 0.40 miles of existing roadway sections. Included as part of the project will be the adjustment or reconstruction of manholes and catch basins located in the street sections. The catch basins will be reconstructed where they are deteriorated and non-functional. A 2 foot wide compacted aggregate shoulder will be constructed on the north side of W. 3rd Street from W. 2nd Street to Illinois Avenue. Partial and full depth repairs are also included for roadway subgrade improvements.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must state full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed in 30 calendar days from the notice to proceed.

All contractors/subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor’s Executive Order of 1972, and the Governor’s Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Trumbull County and the Village of McDonald, Ohio as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614.644.2239.

No bidder shall be considered a competent and responsible bidder or eligible to be awarded the contract to which this Notice applies, if the bidder is listed on the Auditor of State’s database as having a “Finding of Recovery” as that term is defined in O.R.C. 9.24.

Bids shall be submitted on forms provided and shall state the Unit Price or Lump Sum as indicated by the blanks provided therefore; and shall be enclosed in a sealed envelope marked on the outside “2023 Street Resurfacing Project” with the contractor’s name, address, phone number, email address and contact name. The Village of McDonald reserves the right to reject any or all bids and to waive any formalities or irregularities in bidding.
