RESOLUTION ACCEPTING THE BID OF LINDY PAVING INC., 1807 SHENANGO ROAD, NEW GALILEE, PA 16141, FOR THE 2024 STREET RESURFACING PROGRAM WITH A BASE BID OF ONE HUNDRED FIFTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY-EIGHT AND 70/100 DOLLARS (\$157,488.70) AND FOR THE FURTHER PURPOSE OF AUTHORIZING THE MAYOR, FISCAL OFFICER, AND/OR VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH LINDY PAVING, INC. AND EXECUTE ANY OTHER DOCUMENTS NECESSARY TO FURTHER THE PROJECT, and declaring an emergency.

WHEREAS, the Village of McDonald, after advertising according to law, has received and publicly read competitive bids for the 2024 Street Resurfacing Program; and

WHEREAS, Council of the Village of McDonald has determined that the bid of Lindy Paving, Inc. was the lowest competent and responsible bid.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF McDONALD, TRUMBULL COUNTY, STATE OF OHIO, WITH AT LEAST TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING that:

<u>Section I.</u> The base bid of Lindy Paving, Inc. in the amount of One Hundred Fifty-Seven Thousand Four Hundred Eighty-Eight and 70/100 Dollars (\$157,488.70) for the 2024 Street Resurfacing Program is determined to be the lowest competent and responsible bid, and the same is hereby accepted.

<u>Section II</u>. The Mayor, Fiscal Officer, and/or Village Administrator are hereby authorized and directed to execute a contract for the 2024 Street Resurfacing Program with Lindy Paving, Inc., and all other necessary documents to complete the project, in accordance with the terms of the legal advertisement and bid specifications.

<u>Section III.</u> The passage of this Resolution and all deliberations relating to the passage of this Resolution were held in open meetings and in accordance with the provisions of Ohio Revised Code Section 121.22.

<u>Section IV.</u> To preserve the public peace, health welfare and safety, and for the specific reason that the immediate effectiveness of this Resolution is necessary to allow the Village to enter the contract with Lindy Paving, Inc. forthwith so the project can be started and completed in the fall season and before winter, and it shall take effect and be in full legal force and effect, from and after the earliest time allowed by law.
