VILLAGE OF McDONALD, OHIO

ORDINANCE NO. 3306-24

AN ORDINANCE FOR THE PURPOSE OF AMENDING PREVIOUS ORDINANCE NO. 3268-22 CONCERNING THE APPOINTED POSITION OF VILLAGE FISCAL OFFICER CREATED IN ACCORDANCE WITH SECTION 733.262 OF THE OHIO REVISED CODE, and declaring an emergency.

WHEREAS, Council has reviewed the wages and salaries of certain officers and employees of the Village of McDonald and has determined to generally provide certain officers and employees with an increase in wages and salaries; and

WHEREAS, Council desires to pass this amending Ordinance to provide an increase in the hourly rate for the Village Fiscal Officer position.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF McDONALD, TRUMBULL COUNTY, STATE OF OHIO, WITH AT LEAST TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING that:

Clause I. Ordinance Number 3268-22 which presently reads, in pertinent part, as follows:

<u>Section I.</u> In accordance with Section 733.262(B) of the Ohio Revised Code, and due to the vacancy in the position of the Village Clerk, there is hereby created the appointed position of a full-time Village Fiscal Officer. The salary of the Village Fiscal Officer shall be as follows:

- 1. for the first six months of employment \$16.60 per hour;
- 2. for the second six months of employment 17.52 per hour;
- 3. after one year of employment \$18.23 per hour.

<u>Section II.</u> All aspects pertaining to the appointment, removal, and duties of Village Fiscal Officer are set forth in accordance with Ohio Revised Code Section 733.262. The Village Fiscal Officer shall have those powers, duties, and functions as provided by the general laws of the State of Ohio.

Be and the same is hereby amended to read as follows:

<u>Section I.</u> In accordance with Section 733.262(B) of the Ohio Revised Code, and due to the vacancy in the position of the Village Clerk, there is hereby created the appointed position of a full-time Village Fiscal Officer. The salary of the Village Fiscal Officer shall be as follows:

- 1. for the first six months of employment \$17.85 per hour;
- 2. for the second six months of employment 18.83 per hour;

3. after one year of employment \$19.60 per hour.

<u>Section II.</u> All aspects pertaining to the appointment, removal, and duties of Village Fiscal Officer are set forth in accordance with Ohio Revised Code Section 733.262. The Village Fiscal Officer shall have those powers, duties, and functions as provided by the general laws of the State of Ohio.

<u>Clause II.</u> Sections I and II of existing Ordinance No. 3268-22 are hereby repealed and amended as set forth herein.

<u>Clause III.</u> Any Ordinance or Resolution, or parts thereof, inconsistent or in conflict with the terms, covenants, and conditions of this Ordinance are hereby repealed, rescinded, vacated, rendered null and void, and held for naught.

<u>Clause IV.</u> The passage of this Ordinance and all deliberations relating to the passage of this Ordinance were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.

<u>Clause V.</u> To preserve the public peace, health, welfare and safety, and for the specific reason of effectuating the increase in the hourly rate set forth hereinabove to begin on January 4, 2025 in accordance with the budget, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in full legal force and effect from and after the earliest period allowed by law. However, the increase in the hourly rate set forth hereinabove shall not take effect until January 4, 2025.
