RESOLUTION NO. 1924-25

RESOLUTION AUTHORIZING THE EXERCISE OF AN OPTION WITH OHIO VALLEY WASTE SERVICE, INC., THE VILLAGE'S PROVIDER OF MUNICIPAL SOLID WASTE COLLECTION SERVICES, TO REQUIRE THE PROVIDER TO DIRECTLY INVOICE EACH RESIDENTIAL UNIT OWNER FOR THE COST OF THE MUNICIPAL SOLID WASTE COLLECTION SERVICES, INSTEAD OF INVOICING THE VILLAGE.

WHEREAS, after advertising and soliciting competitive bids, the Village of McDonald entered into a written Agreement with Ohio Valley Waste Service, Inc. to provide Municipal Solid Waste Collection Services for the Village with a three-year initial term beginning June 1, 2023 and ending May 31, 2026, and with two potential two (2) year extension terms;

WHEREAS, historically, the Village has paid for the municipal solid waste collection services of its residents, and has continued to do so through the present date;

WHEREAS, upon information and belief, the Village is one of the very few municipal corporations in the State of Ohio that currently pays for the municipal solid waste collection services for residents;

WHEREAS, after much discussion at public meetings, including the 2025 "State of the Village" public forum, and due to the current financial condition of the Village, Council for the Village of McDonald deems it prudent and in the best interest of the Village to no longer pay for the municipal solid waste collection services of its residents and, instead, allow the residents to pay for their own services; and

WHEREAS, the Agreement with Ohio Valley Waste Service, Inc. permits the Village, upon not less than one hundred twenty (120) days prior written notice, to require Ohio Valley Waste Service, Inc. to directly invoice each Residential Unit owner for the cost of municipal solid waste collection and disposal services, instead of invoicing the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF McDONALD, TRUMBULL COUNTY, STATE OF OHIO, that:

<u>Section I.</u> Council hereby authorizes the exercise of the option in the Agreement with Ohio Valley Waste Service, Inc. to require the provider to directly invoice each Residential Unit owner for the cost of municipal solid waste collection and disposal services, instead of invoicing the Village.

<u>Section II.</u> The Village Administrator is hereby authorized and directed to send written notice to Ohio Valley Waste Service, Inc. to require the provider to directly invoice each Residential Unit owner for the cost of the services in not less than one hundred twenty days (120), as provided in the Agreement, and take any and all other action necessary to implement the exercise of this option.

<u>Section III.</u> The passage of this Resolution and all deliberations relating to the passage of this Resolution were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.
