**RESOLUTION NO. 1949-25**

**A RESOLUTION FOR THE PURPOSE OF ACCEPTING THE HEALTH INSURANCE PROPOSAL FROM ANTHEM BLUE CROSS AND BLUE SHIELD THROUGH CORNERSTONE BROKER INSURANCE SERVICES AGENCY, 2102 FLORENCE AVENUE, CINCINNATI, OHIO 45206, FOR THE VILLAGE OF McDONALD OHIO'S EMPLOYEE HEALTH INSURANCE COVERAGE FOR A ONE-YEAR TERM COMMENCING JANUARY 1, 2026 AND ENDING DECEMBER 31, 2026; AND AUTHORIZING THE MAYOR, FISCAL OFFICER AND/OR VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT WITH ANTHEM BLUE CROSS AND BLUE SHIELD THROUGH CORNERSTONE BROKER INSURANCE SERVICES AGENCY FOR HEALTH INSURANCE, and declaring an emergency.**

WHEREAS, the Village of McDonald received quotes for the purchase of employee health insurance; and

WHEREAS, Council for the Village of McDonald has determined that the quote Anthem Blue Cross and Blue Shield through Cornerstone Broker Insurance Services Agency in the amount of One Hundred Ninety-Eight Thousand Two Hundred Three and 04/100 Dollars (\$198,203.04) is the lowest, most qualified, and best quote.

NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE VILLAGE OF MCDONALD, TRUMBULL COUNTY, STATE OF OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING, that:

Section I. The proposal for employee health insurance from Anthem Blue Cross And Blue Shield through Cornerstone Broker Insurance Services Agency to be administered by Anthem Blue Cross and Blue Shield, 4361 Irwin Simpson Road, Mason, Ohio 45040, in the amount of One Hundred Ninety-Eight Thousand Two Hundred Three and 04/100 Dollars (\$198,203.04) a copy of which proposal is attached hereto and incorporated herein as Exhibit A, is hereby determined to be the lowest, most qualified, and best quote and the same is hereby accepted.

Section II. The contract for the purchase of employee health insurance shall commence January 1, 2026 and end December 31, 2026.

Section III. The Mayor, Fiscal Officer, and/or Village Administrator are hereby authorized and directed to enter into a contract for employee health insurance with Anthem Blue Cross and Blue Shield through Cornerstone Broker Insurance Services Agency in accordance with the terms of this Resolution, Exhibit A, the specifications, the contract, and the quote proposal.

Section IV. The passage of this Resolution and all deliberations relating to the passage of this Resolution were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22
